Orcas Recycling Services

- Originally incorporated in 1985 by George Post and others to run The Exchange
- Operated at the Orcas Island Transfer Station (OITS, the "Dump") until the fire (Feb. 2013)
- Bid for County Contract to operate all of OITS:
 - to protect The Exchange
 - return to real recycling on Orcas
- Secured 501(c)(3) status

The County OITS Contract

- 66 pages plus attachments
- Many requirements, limits, cross-references
- 5 years and 1 day; 3 County renewal options
- Notes history of "a reuse facility," at OITS, but:

"The Contractor and County by written amendment of this Agreement <u>may</u> provide for use by Contractor of a portion of the Property as a reuse facility beyond the expiration or termination of this


Agreement . . ." (Emphasis added.)



Milestones

- Operational transition of OITS from County
- Timely Completion/Submission of Master Plan
- Securing required permits and approvals
- Site improvements, longer hours, lower prices
- Cooperative events / stop gap projects
- Recycling initiatives
- Proposal for reestablishing The Exchange







Exchange Site at OITS (aka Parcel B)











Planning for Reuse – The Exchange

- Site Preparation
 - Cleanup of former Exchange reuse facility site
 - Removal and recycling of over 40 tons of material
 - Coordination with Master Plan Improvements
- Review facilities options, costs and benefits
- · Operating policies, procedures and priorities
- Proposal for permanent home, quicker restart



The Proposal

- Acquire an existing commercial building
 - Grandfathered commercial use (approx. 5 acres)
 - Plus approx. 30 acres of Agricultural Land
- Upgrade Building: quickly reopen The Exchange
- Ownership: **Permanent Home** for The Exchange
- Opportunities for efficient composting, etc., and variety of cooperative community programs
- Improve land use consistency, appearance and productivity of the parcel
- Use the OITS space for Recycling



We are **NOT** Proposing

- To move the dump or any garbage activities
- To do "recycling" at the new site
- To fundamentally change The Exchange donation and "pay what you can" approach to supporting operations
- To use donations for The Exchange to subsidize OITS operations OR vice versa

- Environmental Review
- Appraisal (responsibility as a 501(c)(3) Org.)
- Land Use
 - Conditional Use Permitting: nonconforming use
 - · Degree of nonconformity not increased
 - Building Permits for renovation
- Funding
